**PROPOSED CHANGES ON THE FINANCE BILL, 2019**

**1. FINANCE AND ECONOMIC PLANNING**

**Pg. 9.** Move item Code 1-1010 Hire of ground (Court brokers, auctioneers etc) fees per day to sports section

**2. LIVESTOCK DEVELOPMENT, COOPERATIVES AND FISHERIES**

1. Introduce charges on Certificate for Keeping Pets in Urban Areas **(Pg 10)**
  - 1) Dogs - Ksh 500
  - 2) Cats - Ksh 200
  - 3) Reptiles - Ksh 1000
  - 4) Ornamental Birds - Ksh 200
2. Delete item 2-1010 - transportation of livestock – same as movement of stock permit **(Pg 10)**
3. Introduce stock auction landing fee for other livestock **(Pg 12)**
  - 1) Camel/horse - Ksh 300
  - 2) Poultry - Ksh 10
4. Introduce stock auction holding ground charges per day for other livestock **(Pg 12)**
  - 1) Camel/horse - Ksh 150
  - 2) Poultry - Ksh 5
5. Amend stock movement permit for Sheep/Goats/Pigs to be charged per head - Ksh 30 **(Pg 10)**
6. Introduce stock movement permit for poultry/rabbits per head - Ksh 5 **(Pg 10)**
7. Introduce Slaughter House Operations Charges and Fees for:
  - 1) Donkey/Horse/Camel - Ksh 300 (County owned slaughter houses)
  - 2) Donkey/Horse/Camel - Ksh 350 (private slaughter houses)
8. Increase charges on Sale of Manure per ton from Ksh. 100 to Ksh. 500

**3. LAND, WATER, ENVIRONMENT AND NATURAL RESOURCES**

Introduced the following charges

- 1) Forest processing yard permit per year ksh. 15,000

- 2) Penalty for Non-Payment of Cess ksh. 10,000
- 3) Wildlife Conservancy fee 1 % turn over
- 4) Tree/flowers/vegetable nurseries Permit Per year ksh. 2,500
- 5) Royalties for Mineral water 1% of turnover
- 6) Removal of illegal posters/handbills in undesignated areas by the County ksh. 20,000
- 7) Penalty for EIA Non-Compliance per project ksh. 20,000
- 8) Solid waste collection & transportation charges to be paid per year not monthly
- 9) Refuse Collection on crusades/events to be increased from ksh. 1,000 to ksh. 2,000
- 10) Rent for Public Toilets ( up market areas-S/County HQs) to be changed from ksh. 1,500 per month to as per contract agreement
- 11) Forest Resource (Royalties) Companies per year to be charged As Per Natural Resource s Act
- 12) Hire of County Parks for Religious ksh. 4,000, Political rallies ksh.50,000 , Weddings ksh. 5,000, Commercial activities ksh. 6,000, Others e.g. schools institution or travelling musician ksh. 6,000, Tent pitching on Recreational sites ksh. 4,000

#### **4. HEALTH SERVICES AND SANITATION**

- 1) Services offered in all health facilities in the county shall be charged as per the individual health facility service charters charges approved by the CECM Health and Sanitation and prevailing Market Rates.
- 2) Public health Licenses for Hotels to be increased from ksh. 2,000 To ksh. 2,500
- 3) Public health Licenses for Bar & restaurant to be increased from ksh. 3,000 To ksh. 4,000
- 4) Introduce Public health Licenses for Eating houses/cafes with butchery ksh. 2,400 in HQ and ksh. 1,200 in other areas
- 5) Introduce Public health Licenses for Garage ksh. 1,000 in HQs and ksh. 500 in other areas
- 6) Introduce Public health Licenses for Resorts/guest house ksh. 3,000 in HQs and ksh. 2,000 in other areas
- 7) Introduce Public health Licenses for Car wash ksh. 1,000 in HQs and ksh. 500 in other areas

#### **5. EDUCATION & TECHNICAL TRAINING**

- 1) Introduce Hiring of school Premises for weddings ksh. 1,000, Meetings/prayers per day Ksh. 1,000
- 2) Reduce Hall hiring per day from kshs. 2,000 to ksh. 1,000
- 3) Reduce Hall hiring per week from kshs. 10,000 to ksh. 3,000
- 4) Increase Hall hiring per month from kshs. 3,000 to ksh. 10,000

#### **6. ROADS, TRANSPORT,PUBLIC WORKS, INFRASTRUCTURE AND ENERGY**

Introduced the following charges

- 1) Registration of PSV (once) Per vehicle Ksh. 2,000
- 2) Registration of Motorbike per bike Ksh. 500
- 3) Registration of tuk tuk per tuk tuk ksh. 1,000
- 4) Unclamping fee Tuktuk/Motorbike Per tuktuk/ Motorbike ksh. 500
- 5) Unclamping fee Trailer/buses Per Trailer/buses ksh. 1,000

- 6) Delete Impounding Charges Per hour of ksh. 100 per hour
- 7) Wrong parking for All classes of motor vehicles ksh. 2,000
- 8) Parking and damaging drainage covers ksh. 10,000
- 9) Driving on the wrong direction along one way road for All classes of motor vehicles ksh. 3,000
- 10) Parking vehicle on pavement, slab or on drainage covers ksh. 5,000
- 11) Parking on designated pedestrian foot path for All classes of motor vehicles ksh. 3,000
- 12) County Yard Impounding charges for Motorbike Ksh. 1,000, Tuktuk Ksh. 1,500, Bicycle Kshs. 500

## **7. AGRICULTURE AND IRRIGATION**

Introduced the following charges

- 1) Maize , Barley & Wheat Cess for Large/ Medium trader e.g. Millers to be charged at 1% of Produce gross turnover
- 2) Cess for Other categories of small traders cereals eg. Millet, sorghum & Grain amaranth to be charged at Ksh. 30 per bag
- 3) Flower Cess (for export) 20 cts per kg
- 4) Other produce – horticulture cess - Vegetables (for export) 1 sh per kg
- 5) Coffee Cess, tea cess, sisal cess to be charged 1% of Produce gross turnover
- 6) Macadamia Nuts, Sun Flower Cess/Canola to be charged ksh. 50 per 50kg bag
- 7) Beans (Small trader), Soya Beans (Small trader), Pigeon Peas (Small trader), Cow Pea (Small trader), Green Grams (Small trader) to be charged ksh. 50 per 50kg bag
- 8) Sale potatoes seeds to be increased from ksh. 2,000 to ksh. 2,500 per 50kg bag

## **8. TRADE, TOURISM, CULTURE, WILDLIFE AND INDUSTRY**

- i) Rimoi fine for livestock found within the reserve boundary
  1. for cattle (per cow) increased from ksh. 500 to ksh. 2,000
  2. for sheep and goats (each) increased from ksh. 200 To ksh. 500
- ii) Sale of Traditional Belt for Men (ordinary) from ksh. 1000 To ksh. 2000
- iii) Sale of Beaded Rungu from ksh. 2,000 To ksh. 2,500
- iv) Sale of magazine to be reduced from ksh. 500 To ksh. 350
- v) Sale of guide book ksh. 550

## **3. TRADE LICENSE**

Introduced the following charges

- 1) Increase trade license Informal Sector Trader Up To 2 Persons In Verandah or Temporary Building (small kinyozi/ salon/tailoring from Ksh. 1,050 to Ksh. 1,500
