THE ELGEYO MARAKWET FOREST CONSERVATION AND MANAGEMENT ACT

A BILL for -

AN ACT of the County Assembly of Elgeyo Marakwet County to provide for a legal and institutional framework for the sustainable management of forest resources; implement provisions of the Constitution; provide mechanisms for establishment of forests outside public land; entrench public participation in decision making, and for connected purposes

ENACTED by the County Assembly of Elgeyo Marakwet, as follows-

Interpretation.	
Objects and purposes of the Act	(1).This Act shall be applied for the administration and delivery of forest conservation and management in Elgeyo Marakwet County. (2). Without prejudice to the generality of subsection 1 above, this Act shall be applied to – <ol style="list-style-type: none">1. Provide a county-level framework to guide and govern the implementation of the forest policy, including through the County Integrated Development Plan, Sectoral Plans with meaningful public consultations and awareness.2. Put in place and strengthen institutional structure at the county level to support coordination, mainstreaming and implementation of forest activities3. Put in place strategies, actions and interventions to reduce vulnerability to the impacts of climate change by building adaptive capacity, enhancing climate change resilience through forestry activities.4. Map out and Catalyse the County’s transition to cleaner energy sources to lower pressure on forests and trees.5. Incentivize the public, communities and private sector involvement in taking up forestry and tree planting activities including investments.6. Facilitate widespread and participation, ownership and oversight of the County’s forestry activities and integrate implementation of meaningful

Subject to the provisions of this Act, the County Executive Committee member shall exercise control and provide guidance over forest conservation and management, and the implementation of this Act.</p> <p>(2). 	<p>(4) The Director, appointed under subsection (2), shall be responsible for performance of the specific duties and functions of the Directorate set out in subsection (6) below,.</p> <p>(5) The Directorate shall operate under the direction of the County Executive Committee member, and provide advice on matters of legislation, policy, coordination, and the performance of the forestry sector</p> <p>(6) Without prejudice to the generality of the foregoing subsection, the Directorate shall perform the following duties and functions -</p> <ul style="list-style-type: none"> (a) Co-ordination, linkages and oversight over forestry activities (b) Development of a forestry master plan, investment and strategic plans for resource mobilization and financing. (c) Development of County forestry sector standards and guidelines including principles, code of practice, quality assurance, and procedures. (d) Collection and dissemination to the public, from time to time, of information on forestry conservation and management, including challenges and opportunities for improvement. (e) Monitoring, evaluation and assessment of the forestry sector performance.
