

THE ELGEYO MARAKWET COUNTY FINANCE BILL 2021

A BILL FOR

AN ACT of the County Assembly of Elgeyo Marakwet to provide for the amendment of the Elgeyo Marakwet County Finance Act, 2020 in relation to taxes, fees and charges for various services and other revenue raising measures and for matters incidental thereto

ENACTED by the County Assembly of Elgeyo Marakwet as follows –

PART I—PRELIMINARY	
Short title and Commencement	1. This Act may be cited as the Elgeyo Marakwet County Finance Act, 2021 and shall come into operation upon publication

Schedule XII, Alcoholic Drinks License Fees of the Elgeyo Marakwet County Finance Act 2020 is amended as follows-</p> <ol style="list-style-type: none">1) General retail alcoholic drink license in respect of premises situated within a city or municipality reduced from Ksh 50,000 to Ksh 35,000 for 12 months and from Ksh 30,000 to Ksh 20,000 for 6 months.2) General retail alcoholic drink license (off license) in respect of premises situated within a city or municipality be reduced from Ksh 24,000 to Ksh 20,000 for 12 months and from Ksh 14,000 to Ksh 12,000 for 6 months.3) Hotel alcoholic drink license in respect of premises situated within a city or municipality be reduced from Ksh 50,000 to Ksh 35,000 for 12 months and from Ksh 30,000 to Ksh 25,000 for 6 months.4) Restaurant alcoholic drink license in respect of premises situated within a city or municipality be reduced from Ksh 30,000 to Ksh 25,000 for 12 months and from Ksh 20,000 to Ksh 15,000 for 6 months.5) Club alcoholic drink license (proprietary Club or night club or discotheque) in respect of premises situated within a city or municipality be reduced from Ksh 100,000 to Ksh 85,000.6) Supermarket and franchised retail stores Alcoholic license in respect of supermarkets or franchised retail stores for each Premises situated within city or municipality from Ksh 80,000 to Ksh 60,000.
